# **President's Letter**by Monte C. Shalett

Once again, the Season is upon us – let Mirth ring out across the 'Vista as Santa and his Elves come a visitin'! It has been another few months and time has flown. We have been busy as usual with one small break for Thanksgiving. Let me reminisce...

Plans for new homes and additions, pools, fences and all manner of improvements are being sent regularly to the Non-Flood Authority (the NFPAMA, "the Authority") more so than before, but now, more importantly to us and you, they are being sent to our Architectural Committee for review at the same time. As the old saw goes "Measure twice, cut once", please be sure to call Michael Moffitt or contact a board member who can help guide you in your construction ideas. The deed restrictions are in force, as they were before, however we will be able to see potential problem areas in the plan submittals where we were not able to do so before. Everyone should know this: No new construction, whether major or minor, can be started prior to approval of complete construction plans by the Authority. The City of New Orleans will not process building permits without the required approval.

On another very big front, the Authority has also indicated publicly that prior plans developed in 2015 for the rezoning of both public shelter houses and the adjacent parks along Lakeshore Drive have now been put on indefinite hold. Thanks to the Board and to you, our members, who supported our call for action and attended the City Planning Commission meetings, we engaged critical support from all four Lakefront neighborhoods and Lakeview to persuade the Commission and ultimately our partners, the Authority, that better, more compatible use of these buildings should be evaluated. At the current time, no use of the public portions of these buildings other than public shelters has been advocated. The Authority may consider using one of the building's interior space for a Lakefront NFPAMA office for management of the parks and facilities rentals, another new program being formulated.

The Flood side of the old Levee Board (SLFPA-E) has worked with the Non-Flood and has relocated their Orleans Levee District Police Department (OLD PD) from the big building on Franklin Avenue to the Lake Vista Community Center just last month. We now have the addition of their policing on our Lakefront streets to support the Lake Vista Crime Prevention District Metro Security monitoring services. This is a tremendous addition to our vigilance and security and we are assured that with the completion this time next year of the new construction of the OLD Police Complex which just broke ground last week, up to 40 OLD PD Reserve officers will remain at the LVCC Office for a long-term anchor on the Lakefront. This is absolutely due to Joe Hassinger SLFPA-E President (Lake Terrace resident) and Wilma Heaton, NFPAMA Chairman for their dedication and innovation! Bravo and a big Thank You!

Part of the continuing and considerable improvements by the Authority in partnership with us this past year are improved communications, grass cutting, attention to trees, parks, pass-through servitudes and warnings or ticketing of golf carts in parks and illegally parked trailers and boats on our streets. These are issues for all of us and have been so many years.

Our furry friends became a dark force in the 'hood, striking not just once but often and repeatedly near St. Pius. I am talking about the Attacks of the Squirrels. At least when I am out of office, I will have something to remember over drinks and laugh about as I recall the Mayor dispatching a crack team of animal control officers who "apprehended three of the culprits"!

We have improved the quality of Lake Vista News and our Editors, Brenda and Dawn are proud that we have been able to increase our advertising as well.

Rachel has been steadily increasing the social scene with a wonderful Halloween Party attended by the biggest crowd I have ever seen (MLVGA)! and the costume contest was a hoot, being won by our past Treasurer and her merry band of Killer Squirrels (oh no! Not the Squirrels again!). Next up will be our newest treat, a King Cake Party after the New Year!

Sadly, our two-time President and the anchor of our ship on the Board, John M. Davis, Jr., passed away unexpectedly leaving us without his wit, charm and wisdom. We will miss him. Our Board is going to remember John with the planting of a tree which will grow with every passing year.

- 1. Call Orleans Levee District Emergency Phone Number: 504-283-9800
- 2. Call Metro Security: 504-835-5421
- 3. Call 911 to alert NOPD.
  - a. Metro provides security escort when you are on your way home in the evenings.
  - b. Call Metro to let them know if you will be out of town and they will patrol around your home more often.
  - c. As part of our contract with Metro, they will pick up your mail, newspapers and packages and put them somewhere safe if you request this service

LVCPD now has the ability to download data within minutes from the crime cameras so please be sure to notify us if you have an incident at your home or a neighbors.

# Circles, Lanes and Parks:

### **CIRCLES ON THE NORTH SIDE OF FLORAL PARK**

Our third and fourth articles in this series will cover Circles on the north side of Floral Park.

As many of us know, Lark Street is the major street in east section of Lake Vista and it runs east to west off of Beauregard Avenue. Last time, this series covered the North Lark Circle so we will focus on the South Lark Circle this time. Lark Street is one of the three major streets in Lake Vista. Spanish Fort and Wren Street are the other. It is well known to contain many leaders throughout the existence of LVPOA, LVGC, and LVWC. Three former LVPOA Presidents live or lived on Lark.

Lark Street ends on what is known as the Movie Theatre lot now occupied by a beautiful home built by the Napolitano family. We hope all of you in Lake Vista have a very special Holiday Season! The wintery conditions we are now in may mean a return to normal for all of our plants in 2018.





# LAKE VISTA WOMAN'S CLUE

The Lake Vista Woman's Club has been busy this fall! Debbie Schmitz, EJGH Cancer Care Navigator, was our guest speaker at our October meeting in honor of Breast Cancer Awareness Month. She brought along several "breast busts" and taught us the proper technique for Breast Self-Exam. She also provided lots of goodies and educational materials and helped make the meeting educational and fun.

In November, in lieu of our annual Wine Social, the members opted to support and attend the 3rd annual K9s for Warriors fundraising event by "A Toast to Our Heroes". The LVWC had about twenty members (2 tables) in attendance and enjoyed cocktails, food and dancing with entertainment by "Lost in the Sixties". This event is held each year to honor and raise money to provide service canines to our Warriors suffering from Post-Traumatic Stress Disability. The goal is to empower our Veterans and return them to civilian life with dignity and independence. K9s for Warriors does not just save Veterans, the organization saves neglected dogs as well. Most of the dogs come from shelters throughout the South Eastern United States. These dogs are rescued and receive professional training for six months before spending three weeks bonding with their assigned Veterans in the real world.

As of this writing we are preparing for our Annual Holiday Luncheon. This year's luncheon will be held at the lovely home of Babs Mollere on Robert E. Lee. Our biggest fundraising effort will be the Auction and Parade of Prizes. Last year we raised almost \$2,000.00 and hope to once again raise money so that we can donate to worthy charitable causes throughout the year.

At our January meeting, the LVWC will be celebrating 63 years! A presentation will be given by Eric Hartman, Executive Director of the Choroideremia Research Foundation. Choroideremia is caused by a genetic defect of the X-Chromosome, and typically only males suffer the full effects of complete blindness, while females are carriers of the disease. There is currently no cure, but a Gene Therapy treatment is now in Human Clinical Trials in the U.S. The LVWC will be presenting Mr. Hartman with a donation for his organization. # Lake Vista Tree Reforestation Plan

While at first glance, it may appear that Lake Vista's tree canopy is substantial, the reality is that Lake Vista has suffered major tree loss especially since Hurricane Katrina. We all know that trees increase property value and are esthetically pleasing but there is more. According to Susan Burley, founder of Sustain our Urban Landscape (SOUL NOLA), "trees are critical to helping manage storm water because they drink it up, thereby keeping it out of the vulnerable storm water drainage system". She goes on to say that New Orleans is the most deforested city in the United States and the City can accommodate a million more trees than we currently have.

To address this issue, the Lake Vista Garden Club is promoting an opportunity for property owners to buy a tree(s) for their property at a volume price discount. We have negotiated with Roussel Outdoors, a licensed and insured contractor to plant a selection of trees especially for Lake Vista. The guidelines are as follows:

- 1. Each tree installed will be approximately 8-10' tall or a 45 gallon size container.
- 2. Cost of \$355 includes the site prep work, tree installation, staking, watering bag, and mulch. Checks made payable to the installer.
- 3. Trees must be planted in accordance with property restrictions and proper permits, if required.
  - A. Trees planted on park/lane servitude will require an Orleans Non-Flood Asset permit. (within approximately 15' from center of lane sidewalk)
  - B. Trees planted on the street side servitude will require a Park & Parkways permit. (We will help determine if you need a permit from Parkways)
  - C. All permits are free.
  - D. Trees planted on your lot do not require a permit.
- 4. Utility markers will be provided by installer.
- 5. Once you decide to purchase tree(s) you will work with the contractor as to a good placement of the tree(s).
- 6. Trees will be planted in January-February.
- 7. Property owners will be responsible for watering the tree, essential for the first year.

This is an incredible opportunity to contribute to not only the beauty of Lake Vista for now and future generations but most importantly contribute to Lake Vista's green infrastructure.



### LVPOA partnership with NFPAMA Progress Report by Michael Moffitt

As we move into 2018 it is valuable and fun to look at how far we have come in 2017. We struggled for the entire year of 2016 to get access to plans for new and remodeled residences so that we could prevent violations of restrictions before they were permitted. Early last year we began receiving these plans and engaging in a dialog with the Levee Board prior to their approval of permit applications. This began a process of discussions and debate about how the restrictions have and have not been enforced in the past, and how they should be enforced in the future. Several of the homes built or begun in 2017 were approved before this process, but in considering the plans we have reviewed, NFPAMA and LVPOA have consistently spoken with one voice.



We have also seen an increase in participation from our members and neighbors in alerting us to unpermitted construction. We need to press the city more aggressively to act on these notices and are working through Peter Waggoner in Councilman Brossett's office to do so. We still have many ways to improve our neighborhood including drainage issues, care for the parks and lanes and continued communications with new residents and Architects about what makes Lake Vista special.

The greatest asset we have going forward is an open and productive working partnership with the Non-Flood Levee Board, including their Executive Director Jesse Noel and his staff. In his article below, Jesse shares his accomplishments and goals with all of our residents so that you may better appreciate the value of this partnership.

### Lake Vista Residents,

I would like to take this opportunity to share how our team has been working with your leadership to help improve the area you call home.

Upon my arrival in March of this year, it was apparent that the LVPOA was eager to partner in the restriction review process and to that end, we have included key members of the association on all review applications submitted in Lake Vista. We have worked together to clarify review criteria and produced some definitions that accommodate the intent of the restrictions and clarify the interpretation the NFPAMA utilizes for reviews. Following community requests, we are implementing changes to our Letters of No Objection and Location Agreements to include language ensuring compliance with the building restrictions and guaranteeing lakeshore subdivision residents access during events respectively.

We have worked together to ensure that access servitudes as well as the parks remain open and free of obstructions to ensure access for both residents and maintenance personnel. We are working with the NFPAMA Subdivision and Recreation Committee to issue new contracts for turf maintenance throughout the NFPAMA properties to increase quality.

It has been my pleasure to begin learning about the lakefront communities and to attempt to refine the processes that govern the maintenance of the community's aesthetic. I hope to continue to build on the partnerships we have developed and to ensure that the Lakeshore Area subdivisions get the services they deserve from the Non-Flood Protection Asset Management Authority.

The Non-Flood Protection Asset Management Authority is responsible for operating and maintaining the non-flood protection assets of the Orleans Levee District which include the Orleans Marina, the Lake Vista Community Center, the Lakefront Airport, the South Shore Harbor Marina, the New Basin Canal Park, the Lakeshore Drive Park and Recreational Facilities, and the neighborhood parks associated with the Lakeshore, Lake Vista, Lake Terrace and Lake Oaks subdivisions. 
