Thirty day cancellation clause

All work authorized by this permit shall be conducted between 7:00AM-6:00 PM Monday through Friday. No work authorized by the permit shall be conducted on Saturday or Sunday.

All work authorized by this permit shall be commenced and completed with 15 consecutive calendar days of the date set forth below under the signature of the LMA. This permit shall be null and void and of no force and effect 16 consecutive calendar days after the date of its issuance.

Photographs of the tree(s) on which the work will be performed under this permit shall accompany the application for this permit. Photographs of the tree(s) after the completion of the work under this permit shall be sent to the LMA within 10 days of the completion of the work. The photographs shall be e-mailed to LMA at the following e mail address: [permits@nfpama](mailto:permits@nfpama).

Any acts taken in violation of any provision of this permit shall be punishable by a fine of \$1,000 for each act in violation of this permit. This fine will be in addition to the other remedies available to the LMA and any owner of any house within 200 feet of the tree(s) that are the subject of this permit ( each an “ Interested Party”).

The property owner and the contractor shall indemnify the LMA, the OLD, SLFPA-E, and each Interested Party ( each an “Indemnified Party”) from and against all losses, costs, damages and expenses ( including attorney’s fees) (collectively, “Losses”) suffered or incurred by any Indemnified Party , directly or indirectly, as a result of or in connection with any act in violation of the terms of this permit or from any personal injuries, including death, or property damages resulting from the work.

Each Interested Party shall be a third-party beneficiary of this permit and is hereby authorized to pursue the property owner and the contractor for any Losses suffered or incurred by such Interested Party for any violation of this permit by the contractor as if such Interested Party was a signatory to this permit.

This permit shall not be assigned by the contractor or property owner to any person.

All work performed pursuant to this permit shall be in a first class and workmanlike manner.

The contractor shall, within five days of the completion of the work authorized by this permit, restore the area in which it conducts the work authorized by this permit to the same condition it was in immediately prior to the commencement of the work authorized by this permit.

The Licensed Arborist listed above shall be at the site of all work authorized by this permit at all times work is being performed by contractor pursuant to this permit.
